6. The bids will be opened in the presence of Bidders' representatives who choose to attend at the Office of *Kalaiya Sub-Metropolitan Kalaiya Bara*. Bids must be valid for a period of **90 and 45 days** after bid opening and must be accompanied by a bid security, which shall be valid for 30 days beyond the validity period of the respective bid. If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in following account and submit the receipt of the deposited amount of cash along with the bid:-
