- Sealed bids must be submitted to the Office of *Kalaiya Sub-Metropolitan City*, Kalaiya Bara by hand/courier before the deadline. Bids received after this deadline will be rejected.
- The bids will be opened in the presence of Bidders' representatives who choose to attend at the Office of *Kalaiya Sub-Metropolitan* Kalaiya Bara. Bids must be valid for a period of 90 after bid opening and must be accompanied by a bid security, which shall be valid for 30 days beyond the validity period of the bid.
